MISSIONS IMPACT

Week of Hope. We celebrate 65 Good Shepherd students and leaders serving with eight different organizations such as nursing homes, community gardens and special needs groups. After working at a YMCA camp during Week of Hope, one college student realized God's call for him to teach children and switched his major: from culinary to education! Another student said, "I felt like God was so ... there. I see Him moving through others." This was our first mission trip since the pandemic began in March 2020.

Tornado Relief. On June 20, Naperville, Woodridge, and a few other communities were impacted by an F3 tornado. Good Shepherd immediately opened our church to anyone without power for internet access and a meal. We mobilized teams to assist with clean-up projects, minor home repairs, providing meals, and moving residents whose homes were deemed uninhabitable.

Although spending was far below budget, it was not enough to overcome the gap in offering, so we expect to finish FY20-21 with a negative bottom line. In what ministry areas have you served/participated at Good Shepherd?

Offering Counter, Cheryl's Children's Home, World Vision (in Uganda) child sponsorship for over 20 years, High School Work Camp, small groups, A Gathering of Men, Quilting, worship serving team, painting, Shady Oaks renovation, Rebuilding Together, VBS, Feed My Starving Children, and Worship Arts (writing and acting in dramas).

Share how you came to Good Shepherd. We knew Pastor Berg, who, like Roger, had also been a nuclear submarine officer. **The messages we heard from him, and continue to hear regarding the New Testament are a huge aid in steering our life, especially in today's hyper-charged atmosphere.**

What inspires you to give and how has that changed over time? We have recognized many needs in our area and across the globe, both material and spiritual. Funding ministries and missions through Good Shepherd provides a tangible response to people's problems that we believe will help them come to know Christ. The fellowship we enjoy at Good Shepherd cements this belief.

How have you been challenged in your giving and discipleship journey? Like many others, we initially lived at a level that left a small margin for giving, but gave to our church, even when we were both graduate students. Over time, our challenge has been to increase our giving, which we have been doing, to great personal reward.

Why do you consider Good Shepherd a good investment of your time and resources? We have had congregational leaders, pastors, and staff who are good managers and stewards. As an offering counter, I have seen our procedures evolve to provide greater security and transparency. Also, we have talented and motivated members working within our ministries and missions.

RECURRING ONLINE GIVING. Most online giving is recurring, which is an easy way to help facilitate your generosity. You can also consider re-evaluating your present recurring gifts.

ASSET-BASED GIVING. Unique forms of giving may be good options for you and may even offer tax benefits. To maximize your gifts to Good Shepherd, consider talking to your financial advisor and tax professional about the options listed below.

- Donor Advised Funds
- Qualified Charitable Distribution/IRA
- Stock Donations

CARES ACT. The Cares Act for 100% AGI limitation on charitable contributions has been extended into 2021, which means for individual itemizers there may be a tax incentive for cash gifts made to churches and public charities. With this special deduction, givers are able to deduct up to 100% of their adjusted gross income (AGI) in 2021. For individual non-itemizers, givers who take the standard deduction on their personal tax return are entitled to deduct up to \$300 from their income for cash gifts made in 2021 to churches and public charities (\$600 for married filing jointly). This is in addition to the standard deduction. Contact your financial advisor or tax professional to see how this may apply to you.
